Stacy Peterson



Stacy Peterson was the 23-year-old wife of a police sergeant. She disappeared on October 28th, 2007, after being trapped in an abusive relationship. Many women held in abusive situations can manage to escape when their abuser is at work, but this was not an option for Stacy. Stacy's husband quickly became a prime suspect in her disappearance after it was discovered that his third wife had accidentally drowned in a bathtub. Stacy Peterson had told her psychiatrist that her husband had admitted killing his ex-wife, and that she feared for her own life. Quickly, she was moved

from the status of a missing person to a likely homicide victim.

This case was different from almost all others, because her husband always knew where she was. He used her cell phone to track where she was at all times, so she had no privacy: no escape. Although most people cannot track others by cell phone tracking systems; law enforcement can. His occupation as a police sergeant provided him with the means to watch where she was, and how long she stayed at each location. There was nowhere that was out sight.

The ability of police to use wireless phones as tracking devices is nothing new. All modern mobile phones can be used to pinpoint a person's location using triangulation and GPS. Even phones which supposedly do not offer GPS service actually do. It is just the customer who cannot take advantage of the built-in GPS. This is one of the main reasons why the cellular networks converted from analog to digital technology. The wireless networks were downgraded to a less reliable technology, despite what their marketing departments must contend. There is also an increasing number of RFID chips inside the radial layer of most car tires. The inclusion of these has been stimulated by strong pressure from the U.S. Government, and provide a means for states to precisely monitor the travel habits of all citizens. Sun Microsystems has been [helping](#) tire companies in their research and development of tire RFIDs. The U.S.D.O.T. is spending millions developing [transponders](#) for

all future American cars. Yes, George Orwell would be smiling now.

The Soul Catcher

Let us take a trip back to September 1996 and the birth of the project appropriately named 'Soul Catcher'. Dr. Chris Winter works for the major telephone company British Telecom (BT), and in particular; the Artificial Life Team. Working alongside a team of scientists at BT's Martlesham Health Laboratories near Ipswich, he has been designing a microchip which would fit behind a person's eye, and record every thought, and observation throughout his lifetime. This ambition may well seem optimistic, but for most of us; it remains a terrifying prospect. The microchip would rest on the optic nerve, and utilize the solar power coming through the eye to record everything that the individual saw, whilst transmitting the images through radio waves to a remote computer.

Although he cites only positive uses for the chip, the sinister implications which surround it are far greater than those of any other privacy invader. Indeed, not many people would be comfortable with the state having a copy of their lifetime in video evidence, combined with the very emotions that they felt; residing on a hard drive. He goes on to describe it as a possible "end of death", with the possibility of inserting a lifetime of memories into a newborn baby through the use of this microchip. As you can see, he slowly became more unethical with each proposition of its use.

The Soul Catcher is intended be the greatest invader of privacy that the world has ever known. From its last reports, it was being designed as a transceiver, so it will utilize both incoming and outgoing signals. This means that somebody from the state would have the ability to reshape the emotions of an implant victim to control him, cause torture, or insanity at

will. Soon after the 1996 reports about the project, it rapidly disappeared from the media, along with most Internet articles about it. Several of the long-standing magazines themselves disappeared.

Dr. Rauni Kilde

Dr. Rauni Kilde spoke out against electronic methods of mind control in 1999. As the former Chief Medical Officer for Northern Finland, Dr Rauni Kilde has held the highest medical positions in the province of Lapland. She is a specialist in public health, health administration, and tropical diseases. She is a retired president of the Nursing College of Lapland, and attends lecture circuits that deal with neuroscience, and acts as Finland's representative to the World Health Organization.

She participated in a detailed documentary warning about emerging mind control technologies entitled "Freedom's Angel: Dr. Rauni Kilde". The documentary aired only once, and has since disappeared. Since then, Dr. Kilde appears to have become a routine victim of sabotage, property theft, computer hacking attacks, and a severe car accident. Her warnings of mind control technology have been both forgotten and silenced. More importantly, she seems to have been silenced.

While some of Dr. Kilde's accusations may seem outlandish upon first inspection for most readers; verifiable evidence reinforcing her claims is cited later in this document. The following excerpts quoted below appeared in *The Canadian*, on January 9th, 2007. Some of Dr. Kilde's remarks were taken from the Finnish medical journal SPEKULA (3rd Quarter, 1999).

Regarding plans to microchip newborns, Dr. Kilde said the U.S. has been moving in this direction "in secrecy".

She added that in Sweden, Prime Minister Olof Palme gave permission in 1973 to implant prisoners, and Data Inspection's ex-Director General Jan Freese revealed that nursing-home patients were implanted in the mid-1980s. The technology is revealed in the 1972:47 Swedish state report, Statens Officiella Utradningar.

Are you prepared to live in a world in which every newborn baby is micro-chipped? And finally are you ready to have your every move tracked, recorded and placed in Big Brother's data bank? According to the Finnish article, distributed to doctors and medical students, time is running out for changing the direction of military medicine and mind control technology, ensuring the future of human freedom.

"Implanted human beings can be followed anywhere. Their brain functions can be remotely monitored by supercomputers and even altered through the changing of frequencies," wrote Dr. Kilde. "Guinea pigs in secret experiments have included prisoners, soldiers, mental patients, handicapped children, deaf and blind people, homosexuals, single women, the elderly, school children, and any group of people considered 'marginal' by the elite experimenters. The published experiences of

prisoners in Utah State Prison, for example, are shocking to the conscience."

"Today's microchips operate by means of low-frequency radio waves that target them. With the help of satellites, the implanted person can be tracked anywhere on the globe. Such a technique was among a number tested in the Iraq war, according to Dr. Carl Sanders, who invented the intelligence-manned interface (IMI) biotic, which is injected into people. (Earlier during the Vietnam War, soldiers were injected with the Rambo chip, designed to increase adrenaline flow into the bloodstream.) The 20-billion-bit/second supercomputers at the U.S. National Security Agency (NSA) could now see and hear what soldiers experience in the battlefield with a remote monitoring system (RMS)."

"When a 5-micromillimeter microchip (the diameter of a strand of hair is 50 micromillimeters) is placed into optical nerve of the eye", Dr. Kilde indicates, "it draws neuro-impulses from the brain that embody the experiences, smells, sights, and voice of the implanted person. Once transferred and stored in a computer, these neuro-impulses can be projected back to the person's brain via the microchip to be re-experienced. Using a RMS, a land-based computer operator can send electromagnetic messages (encoded as signals) to the nervous system, affecting the target's performance. With RMS, healthy persons can be induced to see hallucinations and to hear voices in their heads."

Soul Catchers: We Have The Technology

The following is a brief list of U.S. patents for discrete internal tracking systems which could be installed during surgery or other routine medical procedures without victims even knowing about their existence. This list is far from exhaustive. There are likely dozens of others for the U.S. alone.

[U.S. Patent 5629678](#): Apparatus for tracking and recovering humans utilizes an implantable transceiver incorporating a power supply and actuation system allowing the unit to remain implanted and functional for years without maintenance.

[U.S. Patent 4706689](#): The device employs a unique programmable signal generator and detection system to locate and monitor the movement of individuals. It additionally utilizes a physiological monitoring system to signal a warning for the necessity for immediate help. The device is small enough to be *implanted in young children* as well as adults.

[U.S. Patent 6011991](#): A system and method for enabling human beings to communicate by way of their monitored brain activity. The brain activity of an individual is monitored and transmitted to a remote location (e.g. by satellite).

The Process Has Already Begun

On November 1st, 2000, [World Net Daily](#) reported: "A NASDAQ-traded company has finally unveiled its long-touted and highly controversial 'Digital Angel' -- a subdermal microchip implant designed not merely for keeping tabs on pets, but for widespread, worldwide use in tracking human beings. Digital Angel 'will be a connection from yourself to the electronic world. It will be your guardian, protector. It will bring good things to you,' said their chief scientist, Zhou. 'We will be a hybrid of electronic intelligence and our own soul,' he added."

In October of 2003, Wired News reported: "Solusat, the Mexican distributor of the [VeriChip](#), a rice-size microchip that is injected beneath the skin and transmits a 125-kilohertz radio frequency signal. It is marketing the device as an emergency ID under its new [VeriKid](#) program. The service has even garnered the backing of Mexico's National Foundation of Investigations of Robbed and Missing Children, which has agreed to promote the service. The company envisions placing walk-through scanners similar to metal-detector portals used in airports, in malls, bus stations, and other areas where a missing child may appear. VeriChip manufacturer Applied Digital Solutions said it plans to roll out the VeriKid service in other countries, including the United States, in the future."

On August 23rd, 2006, Nick Farrell of [The Inquirer](#) wrote: "THE FLORIDA outfit which makes implanted RFID chips is lobbying the US government to stick them under the skin of 1.4 million US soldiers. According to the DC Examiner, VeriChip is hoping to convince the Pentagon to allow them to insert the chips under the skin of the right arms of military personnel instead of the traditional dog tags. The Examiner said the outfit might get away with the idea as it has powerful political connections. Apparently the former secretary of the Department of Health and Human Services, Tommy Thompson, is on its board."

As reported by [Antichips.org](#): "On February 22nd, 2007, the VeriChip Corporation and Alzheimer's Community Care, Inc. announced [their plan](#) to conduct a medical study involving the implantation of 200 Alzheimer's patients with a VeriChip microchip implant. The device will be injected into the patients' flesh for a two-year experiment to study the effectiveness and safety of the implants... Medical experimentation on Alzheimer's patients raises profound issues of informed consent. We strongly believe that cognitively impaired individuals should not be used in medical experimentation of this type. Not only is injecting potentially harmful microchips into people who cannot say 'no' ethically problematic... Since cognitively impaired individuals are unable to give informed consent, their use in medical experiments is highly controversial."

As reported by [Canada Free Press](#), August 13th, 2007, "While the world turned on its axis, Big Brother slithered out of the closet in China this weekend. Population control will cover the whole of Shenzhen City and its 12.4 million souls by August's end. Even their personal reproductive history -- in sync with the enforcement of China's 'one child' policy -- will be included on new 'residency cards' fitted with foolproof computer chips. Population control, guided by sophisticated computer software -- from an American-financed company -- will one day jump the Pacific Ocean to land foursquare in North America. China, Big Brother Britain has already been lost to the trend. The grim news was heralded on Drudge, via the New York Times... The 12.4 million Shenzhen citizens are only the beginning. The Communist Chinese government has ordered all large cities to apply technology to police work and to issue high-tech residency cards to 150 million people who have moved to a city but not yet acquired permanent residency... 'If they do not get the permanent card, they cannot live here, they cannot get government benefits, and that is a way for the government to control the

population of the future,' said Michael Lin, the vice president for investor relations at China Public Security Technology, the company providing the technology."

The Preferred Victims

The reader may have noticed a disturbing trend in the events cited above. Whether the chip experiments are upon Alzheimer's patients in nursing homes, young children, military personnel, or the subjects of a totalitarian communist state; these evil promoters carefully pick victims who cannot voluntarily consent -- or refuse. Their every action has demonstrated that their expressed code of ethics, which includes informed consent, is a lie. They are people without conscience, or any moral compass. They excitedly wait for a time when we will not be given a choice either. Perhaps they will be promoting Soul Catcher when that time comes.

The Long History Of Brain Manipulation

There is a long history of research and development behind the current state of tracking and brain manipulation, which began in 1950. I wish to thank [buzzflash](#) for providing the information listed below, which has been condensed for length.

"In 1948 Norbert Wiener published a book, Cybernetics, defined as a neurological communication and control theory already in use in small circles at that time. Yoneji Masuda, 'Father of the Information Society,' stated his concern in 1980 that our liberty is threatened Orwellian-style by cybernetic technology totally unknown to most people. This technology links the brains of people via implanted microchips to satellites controlled by ground-based supercomputers."

1950: Robert Heath and Dr. Russell Moore, funded by the U.S. military and the CIA, experiment with mind manipulation by inserting up to 125 electrodes into subjects brains (alongside drugs including LSD).

1953: John Lilly, of the NIMH, discovers that he can simulate a variety of emotions by placing electrodes inside a monkey's brain. Lilly's work draws the CIA's attention and is later described in John Marks' "The Search for the Manchurian Candidate: The CIA and Mind Control" (1979) and George Andrews' "MKULTRA: The CIA's Top Secret Program in Human Experimentation and Behavior Modification." (2001)

May 17th, 1965: A front page NY Times story, "Matador With a Radio Stops Wired Bull: Modified Behavior in Animals Subject of Brain Study" features the work of Dr. Jose M.R. Delgado, inventor of the "stimoceiver", a miniature transponder implanted in subjects minds to control behavior and emotions. He then urges the U.S. Congress to make "control of the mind" a national goal.

May 1st, 1989: Former BBC producer Gordon Thomas publishes "Journey Into Madness, The True Story of Secret CIA Mind Control and Medical Abuse", connecting Jose Delgado views to those endorsed by Sidney Gottlieb, of CIA/MK-ULTRA. He stated, "Dr. Gottlieb and behaviorists of ORD shared Jose Delgado's views that the day must come when the

technique would be perfected for making not only animals but humans respond to electrically transmitted signals".

June 16th, 1995: Time Magazine features an ad for an implantable pet transponder, oddly enough, aside an article about a militia man's fears about the encroaching New World Order.

Nov. 1996: Advertisements for the "Soul Catcher" implant chip, which, as Personal Computer World explains, "will be implanted behind a person's eye and will record all the thoughts and experiences of their lifetime." Dr. Chris Winter boasts to London's Daily Telegraph, "This is the end of death... By combining this information with a record of the person's genes, we could recreate a person physically, emotionally and spiritually".

Sept. 23rd, 1998: Professor Kevin Warwick becomes the first known human to communicate with machines via a microchip implanted in his body. Afterward he admitted, "It does make me feel that Orwell was probably right about the Big Brother issue".

Oct. 15th, 1998: The BBC reports on "bionic brain implants" developed by American scientists. "Over several months, the implant becomes naturally "wired" into the patient's brain as neurons grow into the cones and attach themselves to the electrodes mounted inside," the report asserts.

Sept. 5th, 2001: ABC News journalist Nicholas Regush warns that "mind control" could be on the horizon. "On the bright side, the powers of this science could be used to mend broken and diseased brains," he says. "On the dark side, there would be plenty of opportunity to tinker with consciousness and control human behavior in menacing fashion."

May 1st, 2002: An ABC report entitled, "Scientists Develop Remote-Controlled Rats" describes a Defense Advanced Research Projects Agency (DARPA) funded project, wherein rats, "each wired with three hair-fine electrical probes to their brains," are "directed through remote control by an operator typing commands on a computer".

May 10th, 2002: A family has microchips inserted into their bodies on national TV (CBS) to acclimate the public to the idea.

Aug. 15th, 2002: During the height of the Summer of the Abducted Child, the Philadelphia Inquirer runs a front page story on the new "high-tech approach to child security": the chipping of children.

March 7th, 2003: An article in the Kansas City Star features University of Kansas professor Jerome Dobson "a respected leader in the field of geographic information technologies" warning that GPS technology may lead to a form of "geoslavery" which could make "George Orwell's 'Big Brother' nightmare ... look amateurish".

March 12th, 2003: The BBC runs an article entitled "Scientists develop 'brain chip,'" which states that "US scientists say a silicon chip could be used to replace the hippocampus, where the storage of memories is coordinated". The testing, beginning on rats and rapidly proceeding to monkeys, will ultimately be conducted on humans.

June 2003: "In a few months, researchers at the University of Southern California will test the world's first prosthetic brain part," Popular Science asserts, crediting Theodore Berger with creating "a 2 mm-wide silicon chip that he hopes will one day substitute for damaged or diseased brain regions". Potential military uses for the brain chip, which was partially funded by DARPA, includes building "sophisticated electronics", and integrating them into human brains to possibly "one day lead to cyborg soldiers and robotic servants".

June 2003: In an article published on DARPA's Web site, Dr. Alan Rudolph explains how the agency's "Brain Machine Interfaces Program" will "create new technologies for augmenting human performance".

April 14th, 2004: The Associated Press blasts the headline "FDA Approves Brain Implant Devices." Citing benefits to those with physical impairments and brain disease, scientist Richard Andersen notes that "surgeons are already implanting devices into human brains -- sometimes deeply -- to treat deafness and Parkinson's disease," and says, "I think there is a consensus among many researchers that the time is right to begin trials in humans".

Ethics: European Union Style

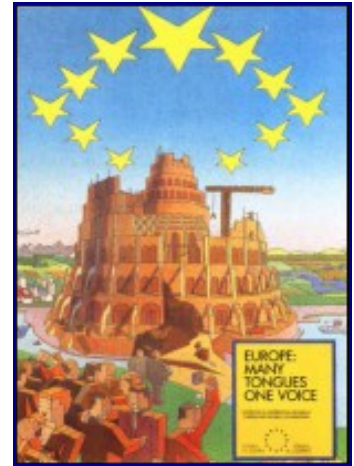

We live in a world in which we are enveloped by a false sense of security, and an illusion of freedom.
